

Statement

On December 18, 2025 Eastern Time, U.S. Customs and Border Protection (CBP) issued a Withhold Release Order (WRO) against automobile tires manufactured in Serbia by one of Linglong Tyre's subsidiaries - Linglong International Europe D.O.O. Zrenjanin (the "Serbian Factory"), suspending the entry into the United States of tire products manufactured by the Serbian Factory (no other facilities/products are affected).

Linglong Tyre hereby declares as follows:

I. Promptly upon issuance of the WRO, Linglong Tyre's management attached the highest importance to it and adopted multiple measures to address the WRO. The Company engaged a legal team with deep experience in CBP enforcement matters to assist in resolving the WRO. The Company has also proactively initiated contact with CBP, including through a meeting to share information regarding the Company's plans to address the WRO. The Company intends to provide periodic updates and information to CBP to seek to resolve the matter. At the same time, the Company has retained an experienced consultancy that specializes in WRO matters to support the legal team in conducting a rigorous and objective assessment of labor and employment practices at the Serbian Factory. The Company will facilitate this assessment, maintain constructive communication with CBP, and work toward an appropriate resolution of this matter.

II. Linglong Tyre attaches great importance to its responsibility to respect human rights and labor rights, uses relevant authoritative auditing standards, and has been a member of the Responsible Supply Chain Initiative ("RSCI") since 2023. The Company is committed to complying with fair labor practices and applicable laws, safeguarding labor rights through concrete actions, upholding the principles of openness and transparency, maintaining constructive dialogue with global stakeholders, advancing sustainable development, and effectively fulfilling its corporate social responsibilities.

美国东部时间 2025 年 12 月 18 日，美国海关和边境保护局（CBP）向玲珑轮胎子公司-玲珑国际（欧洲）有限公司（以下简称“塞尔维亚工厂”）在塞尔维亚生产的乘用车轮胎发出了暂扣令（WRO），禁止塞尔维亚工厂生产的轮胎产品进入美国（其他工厂/产品不受影响）。

玲珑轮胎特此声明如下：

一、WRO 发布后，玲珑轮胎管理层高度重视，第一时间采取多项措施积极应对。公司已聘请在处理美国海关执法事务方面具有丰富经验的法律团队，全力协助处理该事宜；同时，公司已主动与 CBP 建立沟通，通过专题会议等方式向其介绍公司的应对安排与计划，后续将定期通报进展情况，提供必要信息，积极配合 CBP 推动问题妥善解决。此外，公司已聘请一家在处理 WRO 事宜方面具有丰富经验的专业咨询公司，协同法律团队对塞尔维亚工厂的劳动用工实践开展严谨、客观的评估，确保相关工作扎实推进。玲珑轮胎将持续保持与 CBP 的坦诚沟通，推动事件妥善解决。

二、玲珑轮胎始终高度重视并积极履行尊重人权与劳工权益的企业责任，严格遵循相关权威审计标准，自 2023 年起已成为负责任供应链倡议（RSCI）成员企业。公司一贯秉持公平劳动原则，严格遵守业务所在国法律法规，通过务实举措切实保障员工合法权益，坚持开放透明的管理理念，持续深化与全球利益相关方的建设性对话，推动企业可持续发展，切实履行企业社会责任。
